This statement must not be allowed to go unchallenged by any muslim. In it one finds a gross misrepresentation of Islam as it (Islam) was presented and interpreted by the founder of te the Ahmadiyya Movement. In brief this was a beautiful (jamali) exposition of Islam as compared to the powerful and glorious (jalali) one of the Master Prophet Muhammad, peace and blessings of Allah be upon him. Muhammad's miracle was an original and practical creation of a code of living a pure life according to Quranic teachings.

That there can be no mediator between God and man is repeatedly stated in Quran (vide-infra). In fact this is one of the major differences bew between Islam and other religions being propagated today.

The decision of the law-doctors of North India What is your opinion, O men of learning and expounders of law of Islam, in following:

Whether a Jihad is lawful in India, a country formerly held by a Muhammadan ruler and now held under the sway of a Christian Government, where the said christian ruler does in no way interfere with his Muhammadan subjects in the rites prescribed by their religion, such as praying, fasting, pilgrimage, Zakat, friday pra yers and Jamaat and gives them fullest protection and liberty in the above respects in the same waiy as a Muhammadan ruler would do andwhere the Muhammadan subject have no strength and means to fight with their ruler, on the contrary, there is every chance of the war if waged ending with a defeat and thereby causing an indignity to Islam.

The Musalman here are protected by Christian and there is no lihad in a country where protection is afforded, as the absence of protection and liberty between Musalmans and infidels is essential in a religious war and that condition does not exist here.

Besides it is necessary that there should be a probability of victory to Musalman and glory to Islam. If there be no such probablity, Jihad is unlawful.
